### **OTHER DISCUSSION ITEMS**

**President**- New head green's keeper is still indefinitely delayed due to visa issues, no timeline for arrival. (Feb. 13<sup>th</sup> UPDATE: scheduled arrival date of February 19<sup>th</sup>)

### Handicap Director (not in attendance via e-mail): New Business

- 1) <u>"T-Scores"</u>- working with TGA, we have determined that we are over-designating events as "Tournaments" or "T-scores." Per TGA, why is that an issue?
  - The USGA Handicap System has a very specific definition of what should be considered a T-score. Ideally, RHGC should only have 4 or 5 events a year, maximum, designated as a T-score

- Over designating events as "T-scores" dilutes the effectiveness of Section 10-3. By over-designating events as "Tournaments" then there are too many "Eligible T-scores"—see the Handicap Reduction Table in Section 10-3: <a href="http://www.usga.org/content/usga/home-page/Handicapping/handicap-manual.html#!rule-14389">http://www.usga.org/content/usga/home-page/Handicapping/handicap-manual.html#!rule-14389</a>

At RHGC, we have 20+ "t-scores" per year. By classifying too many events as t-scores, the smaller "R" reductions will become. In effect it defeats the purpose of this calculation.

After analyzing historical data and 2017 tournament list with the Handicap Committee, & President & Tournament Director, starting with 2017 only the following 5 RHGC tournament scores will be entered as "t-scores" in GHIN. 1) CEO Cup, 2) May Monthly Medal, 3-4) Club Championship, 5) November Monthly Medal. The rest of the RHGC tournaments will be entered as casual scores. Scores for all RHGC tournaments will continue to be entered by Handicap Committee as before.

#### Action Items

- 1) <u>Indexes</u> -- sent to Dave & Jeff what was approved earlier. <u>Scorecards</u> -- Dave sent inquiry to Aramco contact regarding current scorecard inventory and how to order updated scorecards, we are waiting response. Once we have final certified course rating and updated rules from ground & rules for scorecard, we can update scorecards and systems when RHGC is ready to roll-out.
- 2) Inactivate members from GHIN not on final 2017 Paid Membership list -- Waiting on final Membership list from Membership. Need by 2/20 because I need to update GHIN by end of month.
