Report of the	RHGC has managed 2024 Highlights				
President	1) RHGC has managed the facilities, course and tournaments for the benefit of 685 members over the 2024 season, of which 424 have GHIN handicaps. In total 20,7690 rounds of golf were played, broken down to:				
	11, 672, 9-hole rounds9,118, 18-hole rounds.

- 2) A full tournament diary included 10 Medals, 6 Social events, 13 Tournaments, and 2 seasonal Leagues, with over 2200 rounds of golf played by participants during these tournaments, with the Club Championship still upcoming in December. by 25 events in year.
- 3) RHGC was selected to host an Aramco Invitational Tournament (AIT) Professional Tournament in November 2024.
- 4) Turkish Airlines World Golf Cup re-establish at RHGC in 2024, with 129 players attending
- 5) Increased participation in TNL with many members enjoying the friendly competition and the chance to practice different match play formats
- 6) Another fantastic turnout for Oilman's this year, with a full field of 232 players representing over 30 Event, Team and Prize sponsors. Event popularity is increasing, with more than 10 teams on the waitlist! Several improvement opportunities were identified with a goal of continually improving the event for all participants and sponsors.
- 7) The RHGC events require a great deal of work to organize, and we thank all the volunteers who have given their time to help register players, coordinate "swag bags", marshal events, and assist our Social Director in providing meals, refreshments and entertain for many events throughout the year.
- 8) The Junior Members played 7 events, with 27 families participating, with an average of 14 children per event.
- 9) The Ladies Director ran 18 Tuesday Morning and evening "Nine and Dine" events for approximately 35 members. In coordination with the Golf Saudi Ladies' Program we to help host a quiz night and included the new golfers in a social round of golf with pizza and salad after the round. We provided weekend and weekday lessons with the Pro for much of the year. We have several ladies who are new to the game who have been consistent in playing and growing their skills.
- 10) The Handicap Director mages 424 GHIN accounts. In addition, the introduction of the RHGC Tournament Handicap Indexing tool. This tool uses only competition scores and follows the same calculations as USGA/GHIN, applying them equally to all members. Although not all issues have been resolved, this tool has resulted in more equitable play and reduced negative interactions, as the system is consistently applied to all competitors.

Golf Teaching Professional

In May this year, the Board voted unanimously to amend the Teaching Pro contract to a "6-month winter only" engagement. The decision was based on statistical and financial data; Stuart decided to leave the Club.

To provide some background: The Membership of RHGC pay the salary and allowances for the Pro, however the contract is authorized, managed and signed by Community Services (CS). Since May, the Board has been working with Community Services to work through their processes to authorize a new contract.

Update: On- November 19, the Board was informed by Community Services the process of CS contract management is to be abolished, with immediate effect, and that all Contractors will be procured via a third-party Saudi Company. The cost to RHGC, the business process, the terms and conditions for the third-party company is currently unknown.

This series of events left RHGC in a difficult position, as we were unable to secure the chosen Pro with our intended start date on Nov. 1.

It is hoped that we can now secure the attendance of the new Pro in the first week of January. We will update the membership as soon as we have further information.
